Family medicine residency-initiated school-based health clinic: Addressing vaccine compliance and primary care access



This panel will highlight the Dublin Methodist Family Medicine Residency Program's school-based health initiative, aimed at improving vaccination compliance and reducing absenteeism in Dublin City Schools. The program, staffed by residents, faculty, and school nurses, focuses on providing care to underserved students. The discussion will explore the roles of faculty, residents, and nurses in daily operations, strategies to improve vaccination rates and educate families on preventative care, and how school-based clinics reduce healthcare inequities for underserved students.

The session will cover staffing approaches, effective billing practices, and strategies that support the integration of mental health services with physical healthcare providers and school staff. Best practices for parent and family communication and consent processes will also be discussed.

This session will introduce Ohio AAP's Store It Safe (SIS) program, designed to protect young children from firearm accidents and teens from suicide by firearms, medications, or alcohol. Launched in 2015, the program trains healthcare providers to discuss safe storage, screen for depression and suicide, and distribute resources to families. Participants will learn how to implement SIS in a school-based setting, using the program's resources and strategies to enhance student safety.

Participants will gain a deeper understanding of the reasons behind youth engagement with vaping and cannabis, and how these issues impact students' overall health and wellbeing. The session will emphasize non-punitive, supportive strategies to address vaping and cannabis use, moving beyond traditional disciplinary measures.


